Bharat Bill Payment System - Submission of monthly returns by BBPOUs

All BBPOUs are required to submit the monthly returns as prescribed by Reserve Bank of India (RBI) delineated in Annexure I, II and III by 7th of every month for the previous month with effect from January 2018.

It may be noted that filing of returns is mandatory. BBPOUs are requested to adhere to the above timelines so as to enable us to submit the consolidated returns to RBI on time. We will report NIL returns for the BBPOU to RBI in the event of non-receipt of the information from the said BBPOU.

We request you to take note of the above and bring to notice the contents of this letter to the senior officials of your Compliance Department.
